Dissatisfaction with the options chosen above will NOT result in a discount or refund. Sew Patience & Freedom Quilting, LLC is not responsible for any damage to the quilt from any cause that is beyond its control.
- I understand that a variety of marking methods may be used on my quilt top. Sew Patience & Freedom Quilting, LLC makes every effort to remove the markings before sending back your quilt. There are certain times when faint markings will still be visible. Usually these will come out upon the first laundering of the quilt in cold water. While every effort is made to use removable markers, Sew Patience & Freedom Quilting, LLC cannot guarantee all markings will come out completely. If this is a major concern, consider an edge to edge style for quilting.
- Any quilt not paid within 60 days of final invoice will be sold with the profit retained by Sew Patience & Freedom Quilting, LLC. The deposit will be forfeited.
- Minimum charge of \$65.00 per quilt.
- Should I decide to cancel this quilt order prior to work commencing, I agree that a \$25.00 consultation fee will be retained.
- There will be a \$50.00 fee for any returned checks.
